LOS ANGELES CITY HALL (EAST) VISITOR PARKING

(on Los Angeles Street between Temple and 1st Streets) –

Traveling South on Los Angeles Street, cross over Temple Street and the second driveway on your right will say “201 Los Angeles Street” above the parking entrance. This is the City’s Parking Lot for employees and pre-arranged Visitor Parking. Pull to the right of the Guard Booth and stop. They will have your name and vehicle information. The guard will direct you to the Visitor Parking level. (Pay attention as to where you park so you can find your way back; there are several parking levels.) You will enter the lower levels of City Hall East. Take the elevator to the third floor and take the bridge over Main Street to get to City Hall. You will be going past another Guard Post. You will walk through a metal detector and may be asked to show the contents of any briefcase, etc. you may be carrying. Once you are in City Hall (over the bridge), go straight ahead a few yards past the elevators to the Rotunda – take the hallway to your right. Go down that hall to the end and on your right will be Room 360, Office of the City Clerk (Executive Office).
