> Hi Kerry,

>

> This morning I met with Gary Benjamin. I am the CFO at World of
> Wonder Productions. We are located at the south-west corner of
> Cherokee and Hollywood Bl. It is an office building, with 4 retail
> spaces on the ground floor. The company has owned this building since
> the late 1990's. Gary thought I should talk with you about my
> concerns. The area felt like it was improving during 2013, but during
> the last 6 months things have deteriorated. He mentioned the
> Hollywood BID, which other property owners have mentioned to me, as
> well. I would love to find out more about this, and how we can
> benefit.

> Our specific frustrations are over the growing homeless problem, the
> lack of police patrol, and the lack of police response when we've

> called. We have over 100 employees in our offices here, and many of
> them don't feel safe, especially in the early morning and after the
> sun goes down.
>
> After we lost our corner tenant we thought we would invest in the
> space and have it be a working studio (like BiteSize TV), and a
> gallery/event space. But things feel like they're going in the wrong
> direction, so we're holding off until we get a sense of the city's
> commitment to this area, specifically the blocks east of Highland and
> west of Cahuenga - the no-man's land of the boulevard.
