Hello Gary,

As communicated to Joe Mariani of the HPOA, all documents were forwarded to the Real Estate Services Division of the General Services Department on 3/6/14. It's my understanding that, subsequent to that submittal, Rene also followed up with Real Estate Services staff on behalf of the HPOA.

Unfortunately, I can't provide you with a timetable for approval as we are not in control of the process at this point. Last year we executed two retail leases that took approximately 10 months from accepted Letter of Intent to executed lease. The HPOA was duly advised of the likely delays.

Perhaps, if you contact GSD's Director of Real Estate Services, Melody McCormick (copied here), she can help expedite the approval process.

Sorry for the late reply, it's been a busy week here.

Yes, we originally began discussions with Mayor Garcetti's office (then Councilmember) back in March of 2013. We spoke with LADOT back in April 2013 and were referred to their realtor. It took a bit of follow up but we finally got an agreed up LOI, but were not able to fill out our application until early January 2014. We submitted all necessary materials (articles of incorporation, credit check application, etcetera) at the end of January. Materials were not forwarded to GSD until March 6, 2014. Still no sign of the lease or a move in date.

As far as I know there was no RFP for the property. I hope this information helps. If you need anything else, please just let me know. Thank you again for your willingness to follow up on this. Have a good rest of the day.

### MOTION

The City of Los Angeles owns a public parking structure located at 1710 N. Cherokee Avenue in Council District 13. The parking structure is operated by the Department of Transportation (DOT) and contains a vacant ground level retail/office space ("Suite C").

Suite C has 845 rentable square feet. The space has been vacant since December 2012. The City lacks sufficient staff to issue a Request for Proposals (RFP) for the leasing of the space.

The City received an offer for the lease of Suite C from the Hollywood Property Owners Alliance (HPOA) for an initial term of three (3) years with two (2) 1-year extension options and will generate approximately Fifteen Thousand Dollars (\$15,000) in annual revenue for the first year of tenancy, and includes annual rent escalations, thereafter. Since the space became vacant, no other interest was received by DOT.

The HPOA needs to move in quickly. As such, even if the City had the staff, the issuance of an RFP is rendered impracticable due to the length of time required to execute a lease from this process.

I THEREFORE MOVE that the City Council accept the above findings justify the proposed lease as a sole source contract and instruct the Department of General Services (GSD), in consultation with DOT, to negotiate and execute the lease for the City-owned retail/office space, subject to City Attorney review and approval as to form and legality for 1710 N Cherokee Avenue, Suite C, Los Angeles, CA 90028 with the HPOA.

I FURTHER MOVE that GSD, DOT and City Attorney prepare/process any necessary documents to effectuate the intent of this Motion.
