Hi all -- At this Thursday's meeting, Councilmember Buscaino will be discussing the proposal he and CM Krekorian have put together re: sidewalk replacement. I am on the Consortium's trees/sidewalks/public works committee and we're asking that each of you send in a letter to CM Buscaino, Krekorian and your respective Council rep regarding this proposal.

Don Duckworth (Melrose, Westchester BIDs) has made it easy for us -- he wrote the attached letter that we can all cut and paste. The Citywide Sidewalk Repair Program

details are also attached. The City, it seems, could cite commercial property owners if they did not repair their sidewalks, even if they did not grant permission to remove the trees.

At Thursday's meeting, we will ask for a show of hands to indicate which of our 39 BIDs have these letters in the works. So far 5 of us have sent them in. Let's really show the power of our collective voice and get these letters going!
